Saratoga County

A Brief History

Saratoga County was formed from lands previously belonging to Albany County on February 7, 1791. These lands included most of the Kayaderosseras Patent granted by Queen Anne to 13 of her "loving subjects" in 1708. Saratoga County occupies an important geographical position; bounded on the north and east by the Hudson River and the south by the Mohawk River, the confluence of these two great waterways have made the county a prime destination in times of both war and peace. The northwestern portion of the county is a mountainous area located within the Adirondack Park, while many important rivers and streams such as the Sacandaga and Kayaderosseras dominate the fertile valley areas. The diverse geography of this county has made it appealing to many different people who have chosen to call Saratoga County home.

The Mohawks of the Iroquois Confederacy used this area as hunting and fishing grounds before the Europeans settled here. Many waterways and well-worn Native American trails were used during the French and Indian War (1755-1763) and during the American Revolution. In the fall of 1777 British troops led by General John Burgoyne were headed south along the Hudson River when they encountered a large number of Americans entrenched at Bemis Heights. After two battles, the Americans were victorious and General Burgoyne surrendered to the Americans, led by General Horatio Gates on October 17, 1777. The Battle of Saratoga became famously known as the turning point of the American Revolution.

Saratoga County sits on a geological fault line from which mineral springs push forth to the surface. These mineral waters were thought to have healing powers by the Native Americans and eventually became a much sought-after resource for European settlers here as well. Ballston Spa became a well-known destination for visitors hoping that the medicinal effects of the mineral springs would heal their diverse ailments. Hotels and railroads were built to accommodate the multitudes of summer visitors. Eventually, Saratoga Springs would trump Ballston Spa as the "Queen of Spas" and enjoyed much prosperity through the Victorian Era. Summer visitors came to Saratoga Springs to "see and be seen" by others. Along with the various drink halls, fountains and bathhouses, Saratoga Lake and the Saratoga Race Track became other popular destinations for those visiting the area during summer months.

Saratoga County is filled with various museums, historic sites and parks that preserve the rich history of this area. Both visitors and residents alike enjoy the diverse environmental and historic attractions Saratoga County has to offer.

Focus On *Saratoga County* **Town of Northumberland**

Before Northumberland was established as a township in the early 1700s, the Mohican Indians had two villages there. The Town of Northumberland was formed from Saratoga on March 16, 1798. Colonel Sidney Berry became the first supervisor of the township, which originally included the Towns of Wilton, Moreau and parts of Hadley and Corinth. Northumberland's 32.4 square miles is level and broken by deep ravines. The major stream is the Snookkill, dropping over "Big Hole" Falls, a popular swimming and trout stream. Other main tributaries include Colebrook and Rice Brook.

In 1765, James Brisbin, a native of Scotland, came to Northumberland and settled near Bacon Hill. Fort Miller, built in 1755 under the direction of Colonel Miller, was located on the flat, above the rapids and enclosed on three sides by the river. No trace is left. The western shore of the river was the theater for border warfare. In 1775, Henry Knox led the Patriots from Fort Ticonderoga, moving captured cannons through Northumberland to Massachusetts.

Later a Tory named Hugh Monroe built the first sawmill at Gansevoort, but was compelled to flee to Canada during the American Revolution, and the government confiscated his property. He destroyed his mills before he left. Afterwards, General Peter Gansevoort, the hero of Fort Stanwix, discovered the remains of the old mills. When he purchased the property, he erected a new sawmill and gristmill. Gansevoort was Northumberland's most illustrious citizen and the hamlet of Gansevoort was named for him.

Early settlers were farmers who were attracted to the area for its waterpower potential, plentiful farmlands and forests to log. The first crops required gristmills. To supply farmers' needs, tanneries, blacksmith shops, harness maker shops, and spinning and knitting mills also cropped up. Ferries were established on the Hudson River that enhanced trade and transportation. Pre-Revolution hotels and taverns were also found along the river. Post-revolution, three main hamlets had a mixture of industry, retail and public facilities. The Champlain Canal, opened in 1823, made Northumberland a shipping point for various products raised, made or sold from there.

The town still maintains its rural agricultural character. Many historic sites are connected to the Revolutionary War, including General Burgoyne's "Bridge of Boats" across the Hudson, the British Ovens, Captain John Stark Marker, The Knox Trek Marker, and Stark's Knob. Stark's Knob, which has both geological and historical significance, played a major role with its surrounding topography in the "corking of the bottle" on October 13, 1777, sealing the fate of the British Army.

Northumberland is committed to agricultural and historic preservation, protecting the environment, saving open spaces, and insuring a rural lifestyle for future generations to come.
